7. The holding deposit are non-interest bearing.
8. I accept liability for any tracing/legal cost incurred due to my negligence for the payment and in the event of SOS Prepaid Solutions take any legal action in order to collect payment I will be liable for payment of costs on an Attorney Own Client Scale.
9. I accept I will not be granted indemnity for settlement of my account in the event of not having received it.
10. I accept responsibility for consumption on the premises until such date on which SOS Prepaid Solutions receives written notice of termination from me, of which such notice must be received 14 (fourteen) days prior to cancellation of service.
11. I accept that SOS Prepaid Solution reserves the right to terminate the service due to non-payment of services rendered.
12. I accept that should the incorrect reference be used when making payment resulting in a payment not being allocated my electricity supply may be disconnected and re-connected fee of R450.00 will thus be charged.
